1. Welcome and Introductions

Dr. Mike Holland welcomed the Council members and called the meeting to order at 12:02 pm.

2. Feb. 2021 URC Meeting Minutes

The February meeting minutes had been circulated to the Council and were approved *nem con*.

3. Fee-for-service update

Dr. Jennifer Woodward gave presentation on FFS. Have dedicated team in OSP. Have formal FFS guideline on OSP website, but have 5 guiding principles:

No subsidization

Fair and reasonable pricing

No unfair competition

Consistency

Risk management

4. Updates on Pitt Momentum Funds and Awards Showcase

Dr. Mike Holland gave an update on the Pitt Momentum Funds (PMF), noting that pitches have happened and selections have been made. He explained that, due to COVID, awards will not be rolled out at the Internal Funding Showcase this Spring, as they were last year. Rather than doing one big event, announcements will be made publicly in late March and a website will be created that includes 1-minute videos for each Teaming and Scaling award. An in-person event will be planned for the Fall, enabling the connection of awards to the kickoff of the 2022 solicitation cycle. Preparation is being done in case the event needs to be virtual.

Dr. Holland thanked the committee members who coordinated the review of all proposals and narrowed down selections: Mark Lynn Anderson, Karen Arndt, Velpandi Ayyavoo, Debbie Brake, Yvette Conley, Ray Engel, Brian Galla, Kent Harries, Neil Hukriede, Sean Kelly, Elizabeth Monasterios, Fritz Pil, and Alex Vieira. He then gave a brief overview of winners of the awards, noting 2 \$400K Scaling Award winners, 8 \$60K Teaming Grants, and 20 \$16K Seeding Grants.

Dr. Holland then explained that, now that there have been two cycles of PMF, he and the rest of the PMF team are looking at how things have worked and where there are

opportunities for improvement. He noted that one area that they were not able to accomplish this year was to enable URC coordinators to propose moving applications to other levels if they felt it would be a better fit. He asked that committee members email him and Ryan Champagne with any input or suggestions regarding the PMF process.

Several committee members suggested that it would be helpful to have guidance regarding possible conflicts when, for example, reviewers are asked to review proposals from their own schools. It was noted that there were several reviewers that dropped out of their reviewer roles due to claimed conflict and that better guidance may help to avoid this in the future.

A committee member suggested that an in-person event would be a good way to kick off the next yearly cycle of awards solicitation. The committee member suggested that it would be good to keep the event in September, even after COVID is cleared.

5. Other Business

Dr. Holland stated that Pit has been invited to submit candidates for the Packard Fellowships for Science & Engineering and that 3-4 people would be need to read application packages to help narrow down the selection of 2 nominees from 13 applicants. He asked that anyone who would like to volunteer to do this should email him and Ryan Champagne.

He followed up by noting that there are several more upcoming limited submission awards that they will be looking for help to review, including Sloan Research Fellowships, which are important early-career awards that make someone more likely to be in the running for several later-career awards.

After a question was asked regarding the status of the NIH Instrument Grant Program, Ryan Champagne explained that the program was just announced the previous week and has begun to field applicants. He noted that the internal deadline has been set for April 15, with the NIH deadline being June 1. He stated that anyone with questions about this can reach out to him.

After a question was raised regarding virtual conference platforms, it was noted that Accelevents virtual events platform is supported by Pitt IT and has help available through the helpdesk.

There being no other business, the meeting adjourned at 12:49 pm.
